He worried about "professional ethics" when Mr. Ransom asked if Gildersleeve was buying as many sodas as he used to. "I don't like to violate the confidence of a customer. "(80) He heard a humorous story about a certain local judge but couldn't say if it was Judge Hooker ("Professional Ethics"). (81)

Long before Clinical Pharmacy became fashionable Peavey was practicing it, in his way.

- G: "Have you got a good, reliable sleeping powder?"
- P: "Insomnia?"
- G: (sarcastically) "No, a hangmail."
- P: "Well now I have one customer who used to take the powders because he liked the taste. But he overdid it."
- G: "Did it kill him?"
- P: "About the sleeping powders, Mr. Gildersleeve. Maybe a simple home remedy would be just as effective. Have you tried hot milk?"
- G: "No I haven't. I want something stronger."
- P: "Have you had a number of them? Or was this the first?"
- G: "This was the first, but I want it to be the last."
- P: "Reason I ask is a lot of insomnia is in the mind. Mr. Gildersleeve. Anything been worrying you? You're not nervous about anything? You haven't had any bad news lately?
- G: "No! Peavey, I came here for a sedative. If I want to be psychoanalyzed I'll go to a chiropractor!"(82)

 Peavey had special ideas about the professional aspects of his operation. Leroy got his first job at Peavey's and his telephone response, "Peavey's Pharmacy," was considered "just a little flashy" by the proprietor, who

The dialogue continued:

preferred a simple "Hello."

- p: "And the only otherthing is this, Don't prescribe for people,"
- L: "I thought that was what druggists were for!"
- P: "Pharmacists, Leroy. We are pharmacists!"
- i: "Ob. I forgot."
- P: "No, we never prescribe. I made an arrangement with Dr. Pettibone to that effect some years aso. We agreed that I wouldn't try to cure his patients and he wouldn't make any ice cream sodas."(83)

In spite of his obvious professional qualities, Peavey's image was not all it might have been. Some of that may have been his fault. Leroy was involved in a fight at Peavey's on one occasion. Asked by Gildersleeve to describe the situation, Peavey noted: "I was in the prescription department back there. Suddenly I was awakened by the sound of an altercation." (84) Gildersleeve was, of course, his major antagonist.

- G: "You're the most inefficient druggist in the county." (85)
- on another occasion:
- G: "The trouble with you is, Peavey, all you're interested in is making money."

Peavey's response was the standard, "Well now, I wouldn't say that."(86)

- or another:
- G: "You could take all those medicines you've got there and pour them down the sewer for all the good they'll do you," (87)

Gildersleeve, in one fit of pique called him a "money grubber," (88) and even Floyd the barber could sting in an attempt at humor:

Floyd: "Hi, Peavey, still helping the doctors make business for the undertakers?"

"Well now, I...D.D.D...I resent that!"(89)

Peavey fought back, mildly.-

"Care for an aspiring Mr. Gildersleeve? On the house."(90)

"I'm always glad to give advice, Mr. Gildersleeve, even if there's no profit in it."(91)

His responses tended to ring hollowly, however, in the face of other reactions.

When Gildy threatened to cut off the water of people who were behind in their bills, Peavey wanted to know how many families would be affected so that he could order sufficient soda water. (92) And when Gildersleeve called and asked him to make a house call Peavey resisted. Gildersleeve appealed to him "as a friend" (No response). "as a Jolly Boy" (No response). "as a customer." Peavey: "I'll be right over." (93)

Perhaps these conflicts, and the poor business about which he frequently complained, were the reason for Peavey's apparent discontent. When Gildersleeve asked he hypothetical question: "What would you do if you were Water Commissioner?" Peavey responded that the first thing he would do was sell the drug store. "Forget the drug store," said Gildersleeve. "My, what a pleasant thought," mused Peavey. (94) To be continued next month.


LARRY F. KINER has made a career as a writer specializing in electronics and American discography. His articles have appeared in <u>73</u>, <u>Popular Electronics</u>, and other trade periodicals, as well as in <u>Theme</u>, <u>American Discophile</u>, and similar publications.

Description of Book

Al Jolson first appeared on the Broadway stage in 1911, after having crisscrossed the country on the vaudeville circuit since before the turn of the century. A smashing success, he was signed to his first recording contract. and from then until his death he recorded hit after hit. At the apex of his career, in 1927, he appeared in "The Jazz Singer," in a role that immortalized him and signaled a revolution in Hollywood. The Depression and the advent of radio brought about a decline in Jolson's popularity. After World War II, the movie "The Jolson Story" laid the groundwork for a comeback that rocketed Jolson back to the top of his profession. When he fied in October 1950, his fans, fearing his records would disappear forever from the catalogs, besieged record shops. However, Jolson's recording career was just beginning. Today, more than three decades later, literally dozens of LPs of the man's work, including studio recording sessions, radio broadcasts, movie soundtracks, and hour upon hour of previously unheard performances are available to fans and collectors. "The world's greatest entertainer," as Jolson was billed, is still a most sought-after commodity.

In The Al Jolson Discography, Larry 7. Kiner has put together the complete discography of all known recordings ever offered for sale commercially or recorded for a commercial company and as yet unissued. This volume covers forty years of recordings by the number one entertainer of American popular music. Complete data on recording lates, locations, titles, songwriters, accompaniment, record sizes and speeds, catalog numbers, label names, and the like are given. Indexes to songs, LP albums, single records, conductors, co-stars, motion pictures, and radio series are also provided.

The Al Jolson Discography is a must addition to music libraries, to Jolson collectors, and to collectors of Americana. Students of popular music and of the recording of stage and film will find it a valuable guide to an era.



Super sleuth Stanich writes 'collector's item'

For some, a hobby can turn into an obsession, a true love. So it is with Ray Stanich.

Ray is an ITT Worldcom systems marketing engineer and a 23-year ITT career veteran whose hobby forms a significant part of his life.

It all started about 15 years ago when Ray decided he would like to collect old radio programs. His collection of old radio shows now numbers somewhere around 4,000 to 5,000 Amaziand records—and that's not counting some 1,000 recordings of rare operas (from the Romantic era of 1810-1910).

To collect all those tapes and records, Ray had to do a lot of research. And that research has led him to the co-authorship of a recently published book, *The Sound of Detection: Ellery Queen's Adventures in Radio*, a historical biography of the Ellery Queen radio series.

A couple of years ago, Francis Nevins, Jr., a professor of law at St. Louis University and a mystery writer, approached Ray for some information on old radio shows. Nevins, an Ellery Queen buff, said he would like to write a book on the Ellery Queen radio series, which ran from 1939-1948. Ray offered to research the subject, and their joint authorship was formed.


Their book, published just a couple of months ago by Brownstone Books of Madison, IN, is available in paperback for \$6.95 through mail orders and from specialty bookstores. (Friends and coworkers can also place a "special order" with the author himself.)

Ray, who describes himself as a "puzzle fiend," spends a lot of time attending Old Time Radio Conventions and swapping tapes with other collectors. At a recent OTR convention in Newark, NJ, Ray received the top award for "outstanding contribution to the hobby."

Recently, he joined the lecture circuit addressing convention groups on how to research old radio shows. He was even interviewed on the subject by his favorite broadcast medium—a local radio station.

When asked if he would like to write another book, Ray shrugged his shoulders. "It's hard to find sellable subject matter anymore," he said, "unless I find another interesting project like this one

For a "super sleuth" like Ray, solving The Case of the Elusive Sequel may no prove so difficult after all.
